

Export Administration Regulation by Japanese Government

All of products manufactured in Japan are restricted to export by Japanese Export Regulation, depending on its usage, final destination and so on, which is called Catch-all Control.

Especially, military use and weapon use are prohibited to export without license.

In accordance with the regulation by Japanese government,

KSS decided not to export our products for military and weapon use, except "white country" described in Japanese Export Regulation.

Therefore, all of inquiries from foreign country, KSS needs information about its usage and final destination to export.

In addition, some of the products are no allowed to export themselves without license by Japanese government, which is called List Regulation.

Table below shows whether each KSS product is applicable for List Regulation.

In case of "applicable" with any condition, please ask KSS sales representative.
